Introduction

Boom recognises the need to address climate change by playing our part in reducing greenhouse gas emissions and transitioning to a zero-carbon economy. This Zero Carbon Policy outlines our commitment and aspirations to begin the journey to achieving net-zero carbon emissions across our business and the aim to ensure we work with our supply chain to join us on the journey.

Commitment to Net-Zero Carbon Emissions

Boom are committed to reducing our carbon emissions by 2030 and targeting net-zero carbon emissions by 2050, in line with the Procurement Policy Note (PPN). This commitment applies to Scope 1, our direct emissions, Scope 2 indirect emissions from purchased electricity and heat, and Scope 3, indirect emissions from our supply chain and other activities.

Aspirations and Targets

- By the end of 2024 have a Environment, Social Governance strategy in place that encompass a detailed Carbon Reduction Plan, review and signed off by the Board of Directors.
- By the end of 2024, research, review and implement targets for reducing energy consumption and monitor progress regularly.
- By the end of 2025, review, consolidate, implement a robust and fit for purpose monitoring and reporting software.
- Implement energy-efficient technologies and practices across our head office, satellite offices and sites.
- Increase the use of renewable energy sources such as solar power.
- Transition to a fleet of electric or low-emission vehicles for company operations.
- Working with our supply chain, review, discuss and agree a target for all energy efficient plant to be used on Boom projects. Transition to a fleet of electric or low-emission vehicles for company operations.
- Encourage employees to use sustainable transportation options such as public transit, cycling, or carpooling.
- Prioritise suppliers with sustainable practices and low-carbon footprint products.
- Implement a Waste Reduction and Recycling strategy
- Minimise waste generation through reuse, recycling, and responsible disposal practices.
- Where and when necessary, invest in high-quality carbon offset projects to compensate for unavoidable emissions.
- Prioritise nature-based solutions such as reforestation and conservation initiatives.
- Engage stakeholders, including employees, customers, investors, and communities, in our sustainability efforts and Zero Carbon targets.
- Invest in research and development of innovative technologies for carbon reduction.
